

BIBLIOGRAPHY OF BOOKS AND ARTICLES ON FILIPINO FAMILY AND KINSHIP

JESSE A. N. DIZON

This bibliography was compiled as an attempt to list as many as possible of the more useful books and articles written in English about Filipino family and kinship. It includes literature on the family and kinship of the lowland Filipino majority as well as of minority groups.

In gathering the entries, the starting point was Shiro Saito's *Preliminary bibliography of Philippine ethnography* (Institute of Philippine Culture and Rizal Library, Ateneo de Manila, 1968). Then various books, journals, and other bibliographies like Mario D. Zamora and Jose Y. Arcellana's *A bibliography of Philippine anthropology* (Baguio, University of the Philippines, 1971) and William Henry Scott's *Cordillera bibliography* (Sagada, Mountain Province, Igorot Study Center, 1970) were examined. A preliminary version of the resulting list was sent to the following for comments and additions: Celia M. Antonio, Wilfredo F. Arce, Alfred B. Bennett, Jr., Mary R. Hollnsteiner, Helga E. Jacobson, F. Landa Jocano, Frank Lynch, and Gerard Rixhon.

As compiled, the list is meant to confirm, complement, and expand the selection of basic books and periodicals in the Lynch-Corvera (1969) bibliography also published in PSR (17:51–82). It will do this in several ways: (a) where a book or periodical found in Lynch-Corvera (L–C) is noteworthy for its information on Filipino family and kinship, it will be included here as well, by means of a brief reference to its author, title, and number in the L–C listing; (b) if a book or periodical was *not* in the L–C bibliography, I will give it a complete reference; further if Frank Lynch (whom I consulted) thinks it should be added to his 1969 listing, I will also give the L–C number he assigns to it; (c) in addition to books and periodicals (which alone are within the scope of the L–C listing), *articles* and *unpublished* materials on family and kinship will also be included in the present bibliography.

Entry number in the Lynch-Corvera bibliography;

Other information, in parentheses ().

 Issue number (if available), in parentheses ();
 Page number(s).

For unpublished materials:
